SUMMARY OF INFORMATION:

The Winston-Salem/Forsyth County Schools are requesting initial funding of \$7,900,000 for Building Capital Projects. These projects are to investigate sites, purchase land, design projects and prepare construction bid documents. After the projects have been bid, the schools will request funding for building construction, furniture, and equipment. The new projects include the following schools:


