**SUBJECT: RESOLUTION AUTHORIZING EXECUTION OF NECESSARY DOCUMENTS TO APPLY FOR AN OPIOID ACTION PLAN IMPLEMENTATION INITIATIVE PROGRAM GRANT THROUGH THE NORTH CAROLINA DEPARTMENT OF HEALTH AND HUMAN SERVICES, DIVISION OF MENTAL HEALTH, DEVELOPMENTAL DISABILITIES, AND SUBSTANCE ABUSE SERVICES
(EMERGENCY SERVICES DEPARTMENT – MOBILE INTEGRATED HEALTH DIVISION)**

COUNTY MANAGER'S RECOMMENDATION OR COMMENTS:

SUMMARY OF INFORMATION:

The N.C. General Assembly funded an Opioid Action Plan Implementation Initiative Grant Program through the North Carolina Department of Health & Human Services, Division of Mental Health, Developmental Disabilities, and Substance Abuse Services. The purpose of the grants is to implement strategies to prevent opioid overdoses, increase access to opioid use disorder treatment, and build local capacity to respond to the opioid epidemic in N.C. by funding specific activities highlighted in the N.C. Opioid Action Plan. The N.C. Opioid Action Plan was launched in June 2017. Organizations are eligible to apply for maximum grant funding of \$150,000 for projects advancing one or more of the focus areas identified in the said Plan.

Activities supported through grant funding are divided into two categories described below. Forsyth County Emergency Services Department-Mobile Integrated Health (MIH) Division intends to apply for a grant under Category A to seek funding for peer support positions who can work with the MIH paramedics, which are a part of the post-overdose reversal response team to address all three (3) activities under Category A.

Category A activities include:

- 1) Funding certified peer-support specialists or N.C. certified peer-support training within organizations including, but not limited to hospitals, treatment settings, syringe exchange sites, emergency medical service (EMS) agencies and others to improve linkage to or retention in recovery and treatment;
- 2) Connect justice-involved persons to harm reduction, treatment, and recovery services. This may include establishing or expanding existing pre-arrest diversion programs (e.g. Law Enforcement Assisted Diversion [LEAD]) or post-arrest diversion programs (e.g. recovery courts);
- 3) Establish post-overdose reversal response teams to prevent repeat overdose and connect those who have had a non-fatal overdose to harm reduction, and treatment and recovery supports.

Category B activities are targeted towards syringe exchange programs and training activities that are already being implemented in the community.

WHEREAS, in June 2017, the N.C. General Assembly funded an Opioid Action Plan Implementation Initiative Grant Program through the North Carolina Department of Health and Human Services, Division of Mental Health, Developmental Disabilities, and Substance Abuse Services; and

WHEREAS, Forsyth County Emergency Services Department's Mobile Integrated Health Division seeks to apply for a \$150,000 grant under Category A of the program for peer support specialists to work with mobile integrated health paramedics as part of the post-overdose reversal response.

NOW, THEREFORE, BE IT RESOLVED that the Forsyth County Board of Commissioners hereby authorizes the County Manager or his designee, and the Clerk to the Board to execute, on behalf of Forsyth County, the necessary documents to apply for an Opioid Action Plan Implementation Initiative Grant through the North Carolina Department of Health and Human Services, Division of Mental Health, Developmental Disabilities, and Substance Abuse Services as further described herein, subject to a pre-audit certificate thereon by the County Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney.

RFA Description	<p>The <u>Opioid Action Plan Implementation Initiative</u> has been funded through the North Carolina General Assembly. At this time, State FY 2019 appropriations have not yet been finalized. Therefore, this notification is contingent upon funding availability.</p> <p>The Department of Health and Human Services manages the delivery of health- and human-related services for all North Carolinians, especially our most vulnerable citizens. The purpose of grants awarded under this program is to implement strategies to prevent opioid overdoses, increase access to opioid use disorder treatment, and build local capacity to respond to the opioid epidemic in NC by funding specific activities highlighted in the NC Opioid Action Plan. The NC Opioid Action Plan was launched in June of 2017 with input from stakeholders around the state. Organizations are eligible to apply for grant funding for projects which advance one or more of the focus areas identified in the North Carolina Opioid Action Plan as listed below.</p> <p>To achieve this purpose, all grant funded projects must consist of activities included in the list below. Applicants may propose one or a combination of these activities. Approximately 75% of total grant funds will be apportioned to activities from category A.</p>

	<p>List of activities supported through grant funding:</p> <p>Category A</p> <ol style="list-style-type: none"> 1. Fund certified peer-support specialists or North Carolina certified peer-support training within organizations including but not limited to hospitals, treatment settings, syringe exchange sites, emergency medical service (EMS) agencies and others to improve linkage to or retention in recovery and treatment 2. Connect justice-involved persons to harm reduction, treatment, and recovery services. This may include establishing or expand existing pre-arrest diversion programs (e.g., Law Enforcement Assisted Diversion [LEAD]) or post-arrest diversion programs (e.g. recovery courts) 3. Establish post-overdose reversal response teams to prevent repeat overdose and connect those who have had a non-fatal overdose to harm reduction, and treatment and recovery supports. <p>Category B</p> <ol style="list-style-type: none"> 1. Create or expand syringe exchange programs (SEPs) through local health departments, department of social services (DSS), faith communities, non-profits, pharmacies, clinics, treatment centers, community organizations, and other potential host organizations. Work to build a referral network with SEPs for all required services, including naloxone access and treatment services. Funding cannot support the cost of syringes. 2. Train first responders, community members, or others on naloxone administration 3. Train pharmacists to provide overdose prevention education to patients receiving opioids, increase pharmacist dispensing of naloxone, and link patients to treatment/recovery providers 4. Conduct training on substance use disorder and Medication Assisted Treatment (MAT) for audiences who interact with populations on MAT – e.g., local DSS agencies, court officials, law enforcement, etc. 5. Support training and technical assistance for sites to deliver office-based opioid agonist treatment (OBOT) services
Eligibility	<p><u>Opioid Action Plan Implementation Initiative</u> funds are available to local government agencies (e.g., public health departments, departments of social services, county corrections, EMS agencies, etc.), community organizations, hospitals, health centers, clinics, pharmacies, and other organizations that have a history of work in population health, substance use disorder prevention or treatment, harm reduction, and/or mental health services. Additionally, non-profit organizations that have a history of work with people directly impacted by drug use are eligible to receive funds.</p>
Limitations and Restrictions	<p>Grant funds must be utilized in North Carolina. Funds are reimbursed on an expenditure basis. No lump sum payments will be provided.</p> <p>Grant funds awarded are one-time only funds and may not be carried forward beyond June 30, 2019. Funds may not be used to purchase vehicles or pay down existing mortgages and/or other loans. Funds may not be used for construction of new facilities. In addition, funds may not be used to purchase syringes.</p> <p>Applicants may include requests for capital directly related to their proposed project in their grant application. Applications must include an explanation of why the capital expense is needed in the project description of the grant narrative and complete the capital expense section of the grant budget template. Equipment shall be assigned a control number in the accounting records and shall be tagged individually with a permanent identification number C. Biennially, a physical inventory of equipment shall be taken and results compared to accounting and fixed asset records. Any discrepancy shall immediately be brought to the attention of management and the governing board. D. A control system shall be in place to ensure adequate safeguards to prevent loss, damage, or theft of equipment and shall provide for full documentation and investigation of any loss or theft E. Adequate maintenance procedures shall be implemented to ensure that equipment is maintained in good condition F. Provide a brief (no more than 500 words) overview of your planned project.

Provide your organization name, counties served/operated in and organization type. Describe your organization and its qualifications for funding, including history of work with people directly impacted by drug use.

Assessment of Need(s) (10 points)

Include a description of your organization's needs, population(s) served, geographic area covered by proposed projects, the priority population that this planned project will serve; identified needs of the population served, ability of the project to meet the needs of the population served and community impact. Provide demographic data, including age, gender, race/ethnicity, socioeconomic status, health insurance status, opioid data (death, emergency department visits, and hospitalizations) etc. in the prioritized community. Provide any other pertinent information as it relates to the need for this project in this community. (Note: *Provide citations/reference sources for all community demographic and health status data. Much of the required data is available here <http://www.injuryfreenc.ncdhhs.gov/DataSurveillance/Poisoning.htm>*). Scoring criteria will build in evaluation of need based on state surveillance data

Project Description and Narrative (15 points)

Describe your proposed project Explain how you will engage the priority population in developing this proposed project. Detail how this project will address the organization's needs.
