WHEREAS the County Manager, the County General Services Director, and the City/County Purchasing Director recommend that a contract for the purchase of three 2021 Chevrolet 1500 pickup trucks per bid specifications in the amount of \$27,919 each be awarded to Modern Automotive Network, LLC, for a total contract amount of \$83,757;

NOW, THEREFORE, BE IT RESOLVED, by the Forsyth County Board of Commissioners, that a contract for the purchase of three 2021 Chevrolet 1500 pickup trucks per bid specifications in the amount of \$27,919 is hereby awarded to Modern Automotive Network, LLC, in the total amount of \$83,757 and that all other bids are hereby rejected, and that the County Manager and Clerk to the Board are hereby authorized to execute a contract with Modern Automotive Network, LLC, for the purchase of such vehicles in a total amount of \$83,757, subject to a pre-audit certificate thereon by the County Chief Financial Officer, where applicable, and approval as to form and legality by the County Attorney.
