**ORDINANCE NAMING A NEWLY CONSTRUCTED ROAD IN FORSYTH COUNTY,
“MACY STATION DRIVE”**

WHEREAS, Planning staff requested a dedicated public road recently constructed by NCDOT, located within the unincorporated area of Forsyth County, be named Macy Station Drive; and

WHEREAS, the Addressing/Street naming staff of the City/County Planning Department received no opposition from the adjoining property owners to the proposed road name; and

WHEREAS, the proposed road name does not pose any address range or road name duplication issues and has been reviewed and approved by emergency response agencies; and

WHEREAS, pursuant to the provisions of N.C.G.S 153A-239.1, at least ten (10) days prior to conducting the public hearing to name the said road, Forsyth County caused notice of the time, place, and subject matter of the hearing on this proposed road naming to be prominently posted at the Forsyth County Courthouse, and in at least two public places in the township where the road is located, and to be published in a newspaper of general circulation published in Forsyth County.

NOW, THEREFORE, BE IT ORDAINED by the Forsyth County Board of Commissioners, after providing notice and conducting a public hearing as required by law, that the new public road, as further identified on the attached map, is hereby named Macy Station Drive.

BE IT FURTHER ORDAINED that after naming Macy Station Drive, Forsyth County shall cause notice of this action to be given to the local Postmaster with jurisdiction over the said road, to the N.C. Board of Transportation, and to any municipality within five miles of the said road as required by law.

BE IT FURTHER ORDAINED that this Ordinance shall become effective upon its adoption.

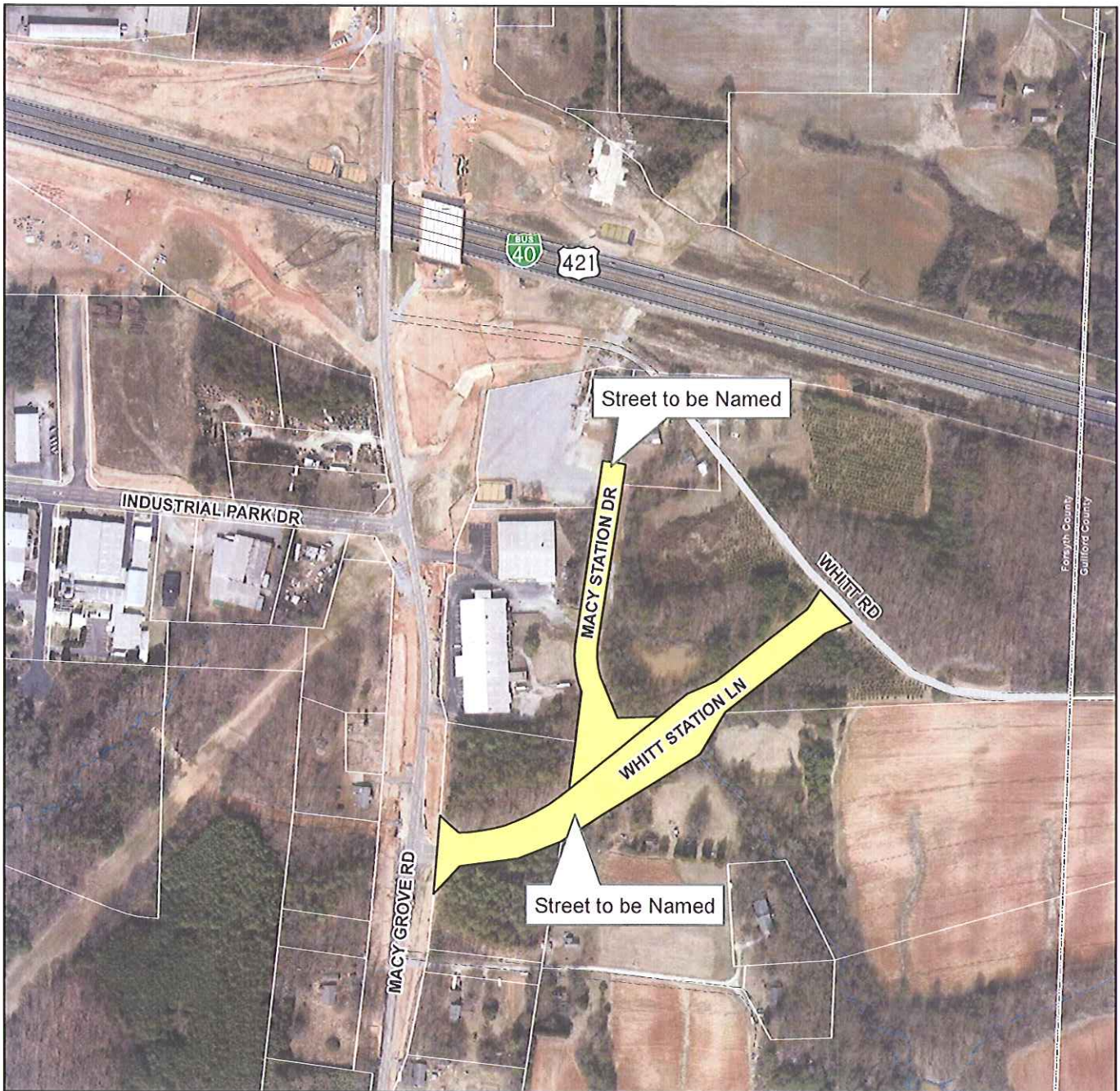
**NOTICE OF PUBLIC HEARING

Notice is hereby given that Forsyth County will conduct a public hearing on Monday, May 11, 2015 at 6:00 p.m. in the Forsyth County Commissioners’ Meeting Room on the Fifth Floor of the Forsyth County Government Center located at 201 N. Chestnut Street in Winston-Salem, N.C. pursuant to the provisions of N.C.G.S. 153A-239.1 on proposed ordinances to name two newly constructed roads within the County, “Whitt Station Lane” and “Macy Station Drive”.

This notice shall be published once at least ten (10) days before the public hearing date in a newspaper of general circulation in Forsyth County, and prominently posted at the County Courthouse and in at least two public places in the township or townships where the roads are located.

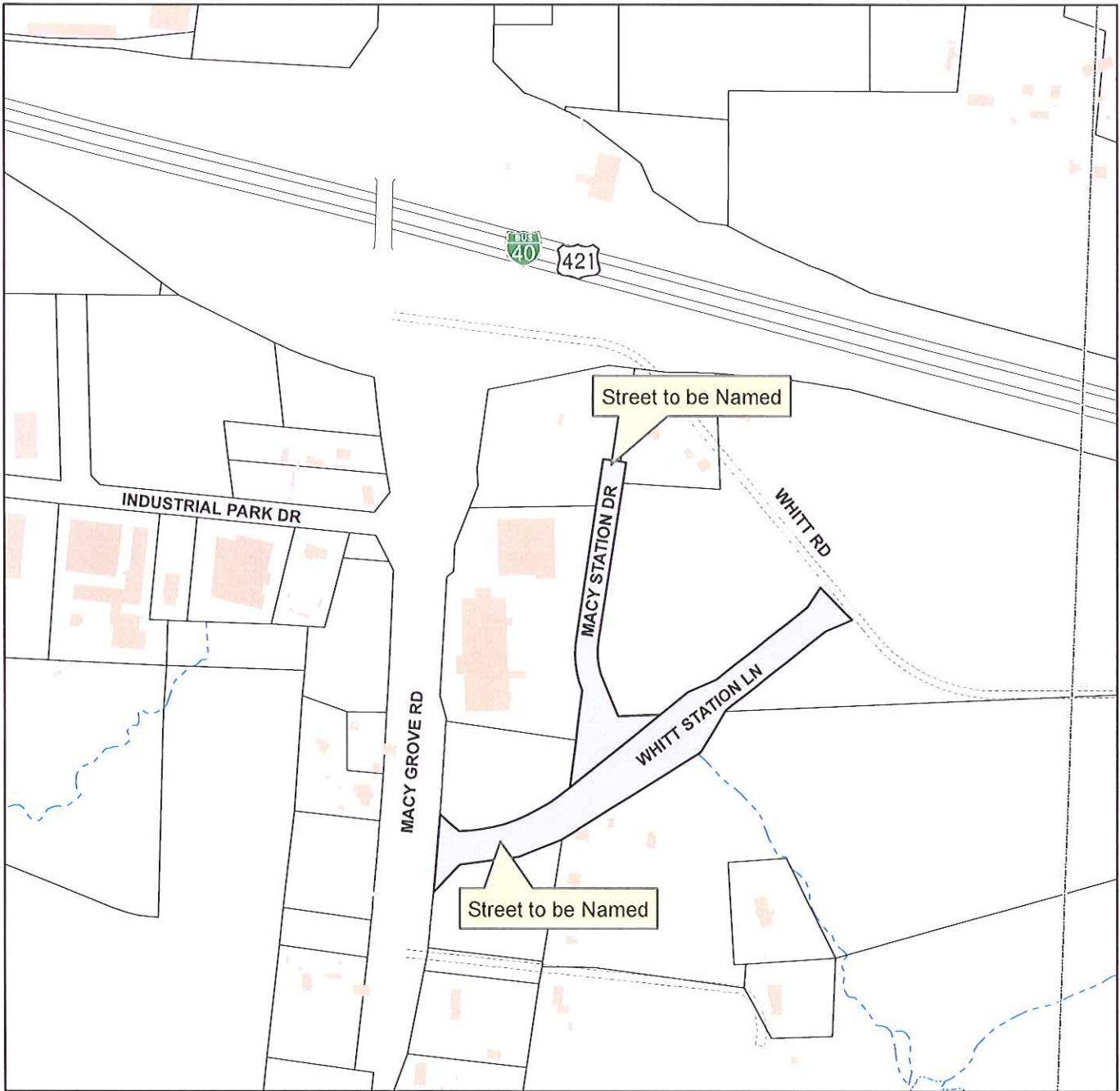
Petition to Name

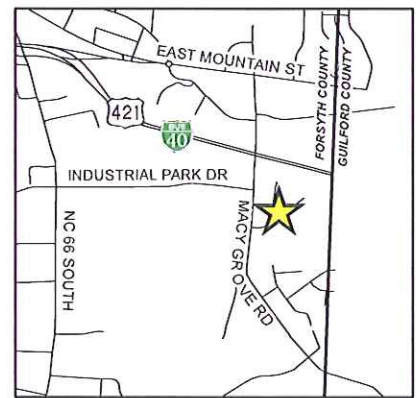
Location Map
